If anything in this document is in conflict with the Bundled Plan's terms and conditions, this document will take precedence. These terms and conditions form an integral part of Your Agreement for the provision of the Service with Us.
- We reserve the right to stop, suspend, amend or otherwise alter this special offer. 2 the applicable charges and any benefits derived through it, as well as these terms and conditions, in accordance with applicable laws. Unless otherwise stated, this will not affect the rest of Your Agreement with Us.

D. Explanation of Charges

- Unless otherwise stated, all charges quoted in this document are inclusive of 1. VAT
- 2. Internet Pause Service Charge:
 - a. The Internet Pause Service Charge as stated in clause C.3.f is a one-time charge that applies when You inform us that you wish to pause the internet service. This will enable You to pause your Internet service while keeping your Fixed Line access number for a period of up to 12 months, without incurring the charges mentioned in clauses C.3.a and C.3.b.
 - b. If the Internet service remains paused for a period of more than 12 months, we
 reserve the right to terminate this Second Residence with Home Pack Special Offer. You will be notified 30 days prior to the termination of Your service.
 - c. If your service is terminated for the reasons listed in clause D.2.b, any Equipment provided to You should be returned to us in good condition. If this Equipment is not returned to Us in good condition, We reserve the right to charge You the penalties as specified in clauses C.3.i to C.3.I, as applicable.
- 3. Monthly Fee:
 - a. The monthly fees stated in clause C.3 apply as follows: i. The charges listed in C.3.b apply as soon as You subscribe to the Offer and are valid until 31st January 2025. From 1st February 2025, the Standard monthly charges listed in C.3.a will automatically become
 - applicable. This charge will be added to Your Bundled Plan's bill. If you do not wish to continue receiving the Service after 31st January 2025 at the Standard monthly charges as specified in clause C.3.a, You should contact Us prior to 31st January 2025 so that We will stop the Service.
- This Bundle is by default an e-billing tariff. This means that You will receive Your 4 bill through electronic means by Using Our e-billing functionality available through Our Website. You agree to register for this functionality and to supply Us with a valid email address where We can notify You when your bill is available as well as to send You other relevant information. Otherwise a charge applies as per clause C.3.i
- Any Equipment We provide You under this Agreement shall remain Our property 5 and should be returned to Us upon termination of the Agreement for whatever reason. If this Equipment is not returned to Us in good condition, We reserve the right to charge You the penalties as specified in clauses C.3.i to C.3.I.

E. Other Information

- This Offer is compatible with the Bundled Plans listed in clause C.3.e. 1.
- You may have up to three (3) instances of this Offer linked to one Home Pack 2. account
- 3. Installation of Home Talk fixed line service will be charged at the rate specified in clause C.3.g.
- 4. You may be required to pay additional charges if You opt for specific billing methods. Further details are available in the Bundled plan's Terms and Conditions
- If Your Bundled Plan over which the Service is provided, is suspended or 5 terminated, this Offer will be suspended or terminated as well.
