A. Your Agreement

- These terms and conditions are for an offer and should be read in conjunction with
 the Bundled Plan's terms and conditions, the General terms and conditions and any
 other applicable terms and conditions. In the event of any conflict between these
 terms and conditions, these terms and conditions shall prevail. These terms and
 conditions form an integral part of Your Agreement for the provision of the Service
 with Us.
- We reserve the right to stop, suspend, amend or otherwise alter this Offer, the applicable charges and any benefits derived through it, as well as these terms and conditions, in accordance with applicable laws. Unless otherwise stated, this will not affect the rest of Your Agreement with Us.

B. Definitions

 stipulated in Clause C.4.b. will apply. This charge will be added to
 Your Bundled Plan's bill.
