



3 months TV Stream Offer Terms and Conditions

These terms and conditions were last updated on 11th January 2023

A. Your Agreement

1. These terms and conditions are for an offer and should be read in conjunction with the GO TV Terms and Conditions, and any other applicable terms and conditions. In the event of any conflict between these terms and conditions, these terms and conditions shall prevail. These terms and conditions form an integral part of Your Agreement for the provision of the Service with Us.
2. We reserve the right to stop, suspend, amend or otherwise alter this Offer, the applicable charges and any benefits derived through it, as well as these terms and conditions, in accordance with applicable laws. Unless otherwise stated, this will not affect the rest of Your Agreement with Us.

B. The Offer

1. This Offer is provided by GO p.l.c ('GO').
2. The '3 months TV Stream Offer' (the 'Offer') is an Offer made available in relation to the GO TV service provided by Us. This Offer is made available to You by signing an Agreement with Us.
3. To benefit from this Offer you must subscribe to the GO TV service and pay €5.99 in advance for 3 months for 1 TV stream.
4. The one-time €5.99 Offer price is for a 3 month period for 1 TV stream.
5. This Offer is regulated by its terms and conditions. By subscribing to this Offer You are agreeing to all the terms and conditions found in this Agreement. If You do not agree with these terms, You should not subscribe or take-up this Offer.

C. Explanation of the Offer

1. Unless otherwise stated, all charges quoted in this document are inclusive of VAT.
2. Monthly Fee:
 - i. The Offer price applies for the first (1st) TV stream for a period of 3 months when You subscribe to the GO TV service.
 - ii. Following the elapse of the Offer period the standard monthly price for the 1st TV stream as listed in clause B.6.b will immediately become applicable.
 - iii. If You would like to subscribe to additional TV streams the charge as listed in clause B.6.c applies.
3. Other Offer Information:
 - a. The Offer is available to new subscribers of the GO TV service as stated in clause B.6.d.
 - b. The Offer starts once the GO TV service is activated.
 - c. Unless otherwise stated, this Offer shall not be available in conjunction with any other offer.
4. This Offer is available for a limited time period.
5. You may be required to pay additional charges if You opt for specific billing or payment methods. Further details are available in clause K of the GO TV Terms and Conditions.

D. Other Important Terms

1. **The Offer is optional.**
2. **In the event that You terminate Your GO TV stream during the 3 month period You will no longer be entitled for the Offer.**
3. **Should You not wish to remain subscribed to the GO TV stream after the expiry of the Offer period, You must contact Us prior to the expiry of the Offer so that We will terminate the TV stream.**
4. **Should You not inform Us of Your intention to terminate the GO TV stream before the expiry of the Offer period, then the standard price stipulated in Clause B.6.b. will become applicable. This charge will be added to Your bill.**
5. **You may stop the Offer at any time.**
