In line with our fair usage policy, we may limit the volume of data allowance whilst roaming in EU Zone 1. Speeds of the internet service and remedies

Mobile data speeds for the GO Smart Plus plan are subject to the type of device and network coverage quality. The mobile network can deliver an approximate maximum download internet speed of 210Mbps and approximate upload speed of 50Mbps when using 4G+ technology. Wherever 5G mobile data service is available, the maximum download speed of 1024mbps and upload speed of 100mbps may be attained.
