Rai Italia+ Add-On TERMS AND CONDITIONS

1. These Rai Italia+ Add-On Special Terms and Conditions (hereinafter referred to as the “Add-On”) are in addition to, and must be read in conjunction with, the terms and conditions regulating the provision of the GO Interactive TV service, the applicable Bundled Plan Terms and Conditions, the Schedule of Charges, and any other applicable terms. 2. This Add-On is provided by GO p.l.c. (“GO”).
3. The Rai Italia+ Add-On is a Video On Demand (VOD) library consisting of selected Italian content which will be made available via GO Interactive TV.
4. The Add-On shall be available from 7th August 2025 until further notice.
5. The Add-On will be automatically provided to You for free if You are subscribed to the GO Interactive TV service including Entertainment Pass. This offer is valid until 1st January 2027.
6. If You are not an active Entertainment Pass subscriber, You may opt to subscribe to the Rai Italia+ Add-On at a monthly fee of one Euro and ninety-nine cents (€1.99), inclusive of VAT. The Add-On is a monthly service with a minimum term of one month. Subscription to the Add-On can be requested by contacting GO Customer Care on 8007 2121, through GO’s website, by visiting any GO retail outlet, or through authorised resellers.
7. If you are an eligible customer or a subscriber, We will do Our best to notify You in advance of any interruption, suspension, termination or change in name of the Add-On wherever reasonably possible. We reserve the right to notify You through an on-screen message when unexpected limitations occur.
8. Eligible customers or subscribers may terminate the Rai Italia+ Add-On at any time by notifying GO through the channels indicated above.
9. Only active residential GO Interactive TV subscribers are eligible for or may subscribe to this Add-On. In the event that a customer terminates their GO Interactive TV service, the Add-On will be terminated automatically and access to the Rai Italia+ content will be discontinued.
